



## Bernice M. Kumm

March 14, 1928 - April 25, 2018

OSMOND -- Funeral service for Bernice M. Kumm, 90, of Norfolk will be held at 2:30 p.m., Saturday, April 28, 2018 at the Immanuel Lutheran Church in Osmond with Rev. Glen Emery officiating. Interment will be in the parish cemetery. Visitation for Bernice will be 4:00-7:00 p.m., Friday, also at the church in Osmond. Bernice died Wednesday, April 25, 2018 at Norfolk Care and Rehab in Norfolk.

Stonacek Memorial Chapel in Osmond is in charge of the arrangements.

Bernice Mamie Brasch Kumm was born on a farm northwest of Bloomfield on March 14, 1928, to Ervin and Annie (Hammer) Brasch. She became a child of God when she was baptized on May 6, 1928, by the Rev. Martin Schrader at St. Marks Lutheran Church at Bloomfield. She was confirmed on March 28, 1942, at St. Marks Lutheran Church at Bloomfield by the Rev. H.O. Rhode. She worked at the 5 & 10 store and bakery in Bloomfield. She married Glen Kumm of Osmond by the Rev. H.O. Rhode on Jan. 23, 1947, at St. Marks Lutheran Church, Bloomfield. To this union three children were born: Barbara, Gaylord and Myron.

They lived 6½ miles west of Wausa where they farmed, sold Triple F feed, and built Kumm Inc. in Plainview where he sold Chief buildings and bins. They belonged to the Golgotha Lutheran Church rural Wausa for 29 years. In March of 1976, they moved to Plainview and transferred to Zion Lutheran Church in Plainview.

Bernice enjoyed making quilts for her children and grandchildren, and crib

quilts for great-grandchildren. She also did embroidery and crocheting. In June 2000, they retired to Norfolk. On July 2001 they transferred to Immanuel Lutheran Church at Osmond. They spent many winters in Mesa, Ariz. Bernice has been at the Norfolk Care Center since March of 2015. Survivors include children Barbara (Robert) Petersen of Osmond and Myron (Peg) Kumm of Wausa; 13 grandchildren, Tony and friend Megan Kumm of Wausa, Luke Kumm of Wausa, April (Jeff) Alexander of Wausa, Nancy Dunn of Pierce, Nila (Mike) Wanke of Norfolk, Gary (Niki) Petersen of Norfolk, Ivan (Karen) Petersen of Norfolk, Ross (Nora) Petersen of Norfolk, Judy deKoning of Summerfield, Kan., Ben (Angela) Kumm of Bloomfield, Glen R.
